Re: Administrative Updates

ACTING CAO UPDATE:

Development Projects:

- As previously reported, the two parcels of land in the LCIP sold to 1199553 B.C. Ltd., is now formally complete and the Developer is working on submitting their Development Permit Application that will likely be considered at the next Regular Council Meeting.
- A rezoning application has been submitted for the property previously known as the "Water Wheel Landing", which is adjacent to the Barriere River near the Barriere Town Rd. bridge. Changes introduced by the *Housing Statutes (Residential Development) Amendment Act* now limit the discretion that was previously afforded to local governments. Amendments to the *Local Government Act* section 464 now state that a local government cannot hold a public hearing where a proposed zoning bylaw permits residential development that is consistent with an existing OCP. As the existing OCP dedicates the entirety of this subject property as 'Residential', this application falls under this new legislation and will be the first the District will consider under this new Provincial regulation. In cases where public hearings cannot be held such as this, the requirement for local governments to give notice, prior to first reading, will also ensure that residents remain informed of the developments taking place in their communities as projects proceed forward. This Notice for this upcoming application, is scheduled in the next two editions of our local newspaper ahead of Council's first reading of the draft Bylaw amendment on March 11th, 2024.
- Staff continue to facilitate initial discussions regarding a number of upcoming and potential developments.

- Along with Mayor Stamer and Public Works Manager, Chris Matthews, participated in a meeting with MOTI regarding their traffic study for the stretch of Hwy 5 between Mountain Rd and Barriere Town Rd. (at the Teniye Market intersection).
- Along with Mayor Stamer, participated in a meeting with Interior Health to discuss their plans to resume same day health services in Barriere and their public engagement plans to hear from various public sectors in our community regarding health needs in the area.
- Will be meeting with Simpcw Band Manager, Rhonda Kershaw, next week to discuss the draft MOU as well as other organizational updates.
