

**DISTRICT OF BARRIERE  
BYLAW NO. 232**

BEING A BYLAW FOR THE LEVYING OF RATES FOR MUNICIPAL,  
HOSPITAL DISTRICT AND REGIONAL DISTRICT PURPOSES  
FOR THE YEAR 2023 AND TO REPEAL TAX RATES BYLAW NO. 218

---

**NOW THEREFORE** the Council of the District of Barriere, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as the “*Tax Rates 2023 Bylaw No. 232*”.
2. The following rates are hereby imposed and levied for the year 2023.
  - a) For general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in the column titled “General Municipal” of Schedule “A” attached to and forming part of this Bylaw.
  - b) For hospital purposes on the value of land and improvements taxable for hospital purposes, rates appearing in the column titled “Regional Hospital” of Schedule “A” attached to and forming part of this Bylaw.
  - c) For Regional District purposes on the value of land and improvements taxable for hospital purposes, rates appearing in the column titled “Regional District” of Schedule “A” attached to and forming part of this Bylaw.
3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
4. This Bylaw repeals “*Tax Rates 2022 Bylaw No. 218*”.
