# DISTRICT OF BARRIERE MINUTES OF A PUBLIC HEARING & REGULAR COUNCIL MEETING

Held on Monday, October 16, 2023 at 7:00pm in the Council Chambers at Municipal Hall 4936 Barriere Town Road, Barriere, B.C.

Mayor Stamer called the meeting to order at 7pm.

#### 1. ADOPTION OF AGENDA

A late entry agenda item was presented by the Fire Chief for approval: 7b UBCM Community Emergency Preparedness Plan (CEPF).

Moved by Councillor Kershaw Seconded by Councillor Kibble That Council approve the October 16, 2023 Regular Council Meeting & Public Hearing Agenda as amended.

#### 2. PUBLIC HEARING

a. <u>RZ-23-03 P2 – Zoning Bylaw No. 111, Amendment Bylaw No. 237</u>: Portion of DL1570 from Small Holdings (SH) to Residential (R)

Moved by Councillor Armstrong Seconded by Councillor Lodge That Council recess the Regular Council Meeting and convene into a Public Hearing at 7:02pm.

#### CARRIED

A Public Hearing opening statement was read by the Mayor. There were approximately 6 members of the public in attendance, both in person and online.

The Corporate Officer provided an overview of the application and attached planning report.

Doug Randall, a representative from the contracted engineering firm acquired by the applicant, made a power point presentation to Council and those in attendance (attached for public record).

Public attendance comments (in person and electronic attendees) presented were as follows:

<u>Chris Delaney (via online)</u> – Summarized his written submission that was included in the agenda package. He expressed that his main point is that he is still in litigation with the applicant and neither party can develop the land until the dispute is resolved. He suggested that if the court sides with him, then that ruling may impact the application and feels it needs to be resolved before rezoning occurs.

<u>Suzanne Turenne (in person / TNRD resident)</u> – Dixon Creek Rd is her subdivision's only way in and out. She expressed her opinion that the road is terrible as it is. She feels it is poorly maintained and worries that the increased traffic will only make it worse. She also stated that during the construction phase and road paving, it will be an inconvenience.

Norm Keinitz (in person / TNRD resident) — Explained that the issue is less about details of the development and servicing issues but is about "use" through rezoning. He stated the question is whether or not the increase of density in that location is appropriate for the District of Barriere and that the benefits vs the disadvantages should be weighed carefully during the debate. He stated that while he does see some advantages, that it is his belief that the proposal isn't a great fit for Barriere, nor does it align well with the TNRD Regional Growth Strategy in his opinion. He concluded his comments that he advocates against the rezoning.

The Mayor called three times for any additional public comment on the rezoning application. No more comments were presented.

Moved by Councillor Kershaw Seconded by Councillor McInnis THAT the Public Hearing adjourn and that Council reconvene into its Regular Council Meeting at 7:50 p.m.

#### 6. BYLAWS and POLICIES

a. Zoning Bylaw No. 111, Amendment Bylaw No. 237 re: RZ-23-03 P2 - 3rd reading

Council debated the application as well as the comments received from the applicant and the public received during the Public Hearing. The discussion included the following:

- It was questioned if there is a timeline for the completion of the Servicing Strategy and it was answered by staff that it would be at the discretion of the applicant.
- It was asked if the subject site should be densified, and it was suggested that there are indeed reasons for a 'yes' answer but there are also some good points for a 'no' answer that were raised tonight by those in attendance.
- It was stated that it does flow with the residential areas below its location as presented.
- The point was made that within the jurisdictional boundary of the municipality, there aren't too many places left to add density.
- The current housing crisis factors into this debate as housing availability is needed and this potential development could attract skilled workers, entrepreneurs and doctors to the area.
- The opinion was voiced that if the zoning of Small Holdings was maintained, the cost to the developer to service those few lots with municipal water would likely not be financially feasible. Other water service options would be challenging.
- The addition of a reservoir to the municipal water system that would be made possible with this development can enhance wildfire protection efforts and increase reserve water for the community as a whole.
- The trail development available in the ALR portion of the parcel is another benefit to the community.
- The statement was made that this new application addresses the majority of the concerns raised by Council during the last application that was ultimately unsuccessful.

Moved by Councillor Kerslake Seconded by Councillor Lodge

THAT Zoning Bylaw No. 111, Amendment Bylaw No. 237 be given 3<sup>rd</sup> reading; and THAT Zoning Bylaw No. 111, Amendment Bylaw No. 237 be held at 3<sup>rd</sup> reading pending the submission and approval of a Servicing Strategy to the District of Barriere prior to final bylaw adoption.

The CAO provided an overview of the written report. Mr. Payette elaborated on the reported meeting with BC Hydro where the larger than normal number of outages and power surges Barriere has been experiencing were discussed at length.

Councillor Kibble expressed that she was very appreciative of the excellent job the CAO did in the discussion with the Seniors Society and helping to dispel the misinformation and confusion regarding the Crown Land application and its impact on the Seniors Centre. Councillor Kibble reported that she has been informed by the Society that they are willing to write a letter of support for the remainder of the Crown Land, but wish to exclude the property that the Senior's Hall and grounds reside.

A budget status update for the Flume Business Centre construction will be brought forward in an upcoming Council Meeting.

The Public Works Manager reported that a hydrogeological assessment is required by the Province for the renewal of the Bradford Well Licences. The CAO suggested advocating for removal or reduction of well licenses for municipal governments providing residential drinking water.

b. <u>UBCM Community Emergency Preparedness Plan (CEPF) Resolution</u> – A. Wohlgemuth, Fire Chief

Moved by Councillor Kerslake Seconded by Councillor McInnis THAT staff be directed to apply for funding in the amount of \$30,000 under the UBCM Community Emergency Preparedness Plan (CEPF) – Volunteer and Composite Fire Departments Equipment & Training.
