On behalf of MLA Milobar, I am sharing the following information from the Minister of Municipal Affairs and Housing regarding the upcoming Request for Proposals (RFP) for the Community Housing Fund, as your organization may be interested in participating.

BC Housing will issue the Request for Proposals on May 27, 2020, and it will be open until mid-January 2021, giving proponents time to prepare their submissions. While the RFP will be open until mid-January, BC Housing will proceed with pre-allocation to successful proponents as early as September 2020. **Subject:** Barriere Affordable Housing

Hi Tasha,

As you are aware the Province of BC has recently announced it's latest call for proposals for affordable housing projects. I'm writing to give you an update on our efforts to date and to advise that it is still our intention to make a submission in response to this call.

I spoke to Ward earlier this week and gave him a verbal update which included the following:

- Phone call and email to Colleen several weeks ago requesting site details be forwarded to our consultant to allow him to determine the scope of the project (number and range of units)
- Atcorr Consultants has been asked to prepare a proforma based on the number of units and utilizing the current BCH funding formula
- Letter from Simpcw has been received supporting the project.
- Request has been made to architect for a visual rendering.
- We will be in touch with BCH in the near future to discuss details of development and specifically the possibility
  of YCS operating programs out of this building. We have had this discussion already and we were advised that
  funding for a proposed daycare would involve MCFD Childcare funding and YCS would need to finance it portion
  of the building.
- We anticipate making a submission to BCH by September which is within the time frames set out by BCH. As Mayor Stamer and I discussed it is likely that a decision by BCH would not occur until 2021. There may be some announcements of projects this fall but in all likelihood these proposals are currently in the queue and are shelf ready.

In preparation for our submission we would need a copy of the housing needs assessment that was recently completed. We will/have been conducting our own survey internal to our staff and client base as well as engaging with other community stakeholders. This, as well as community profile data will form the basis of our submission.

As we proceed the challenging aspect of this project remains identifying a suitable site. One of the properties that we had identified was sold earlier this year and another property we considered was deemed to be inappropriate given its' location on the west side of the highway. The property we are using for the purpose of this proposal is the location owned by the District of Barriere( former HY Louie bldg.)

As we proceed we will continue to keep you updated on our progress.
