# DISTRICT OF BARRIERE MINUTES OF A PUBLIC HEARING & REGULAR COUNCIL MEETING

Mayor Stamer called the meeting to order at 7pm.

## 1. ADOPTION OF AGENDA

2. PUBLIC HEARING - Zoning Bylaw No. 111, Amendment Bylaw No. 224

Re: RZ-22-04 CLA, 4818-4824 Annesty Rd

Moved by Councillor Kershaw Seconded by Councillor Armstrong

That Council recess the Regular Council Meeting and convene into a Public Hearing at 7:02pm.

A Public Hearing opening statement was read by the Mayor and the Corporate Officer provided an overview of the rezoning application and all public comments received prior to the public hearing:

- <u>Jeanne Lockhart</u> (via email) expressed support for the proposed housing project.
- Roy Tattersall (via email) expressed support for the proposed housing project as there is a need for this type of housing in the community for seniors looking to downsize.
- <u>Brad Thiele</u> (via email) Believes this project will enhance Barriere's overall quality of life and would be proud of Council if they show support for the non-profit based initiative that will help the community's elderly.
- <u>Victor Moldovan</u> (via email) Welcomes the initiative as such a project provides a housing option for parents and grandparents. Expressed the opinion that should the

- project be approved, it would be a sign that Council supports a healthy, vibrant community.
- <u>Wade Allen</u> (via hand delivered letter) Believes it is a great idea as simple rentals are needed in the community.

Ms. Buchanan reported receiving a verbal concern regarding septic fields utilized by seniors' specifically due to medication concerns and, in the opinion of the resident, it could affect the town's water source.

## Referral Comments Received:

- <u>Simpcw First Nation</u> Requested that a service agreement for a field assessment be signed with them before any disturbance of soil.
- Interior Health Authority (IHA) Reported an overall support of the project for it provides much needed housing in the community and supports Barriere's Official Community Plan goals. IHA suggested that the applicant consider shade trees to help keep homes cooler in extreme heat events.

After the Mayor called for public comments, the following statements and questions were presented by those appearing in person or online:

- <u>Janet Lanoville</u> (in person) Expressed her opinion that the proposal is a very good idea and needed in the community.
- <u>Dennis Redford</u> (in person) Explained that as a retired wastewater professional, he has
  concerns regarding medication disposal into septic fields as it will make its way to the river
  and town water source. He stated his belief that the local government should invest in a
  traditional, town-wide, sewer system. He isn't opposed to seniors housing in principal,
  however, he believes it should be on a municipal sewer system.
- <u>Al Fortin</u> (online) Will the wastewater system of the development be turned over to the municipality to operate and maintain once construction is completed? Answer from staff: No, just as with any private septic field, the system will remain a private system which is owned by, and is the responsibility of, the property owner.

The Mayor called an additional two times for any further public comments. No further comments were presented.

#### 6. BYLAWS and POLICIES

a. Zoning Bylaw No. 111, Amendment Bylaw No. 224 re: RZ-22-04 – 2<sup>nd</sup>, 3<sup>rd</sup> readings & adoption

The Corporate Officer provided an overview of the draft bylaw. It was also reiterated that the wood-boiler currently on site, will not ever be used to heat the proposed rental units and that individual heat pumps are planned.

Discussion ensued.

- It was asked to the property representative present as to what the long range plan is for a maximum number of occupants is anticipated to be. Mr. Lockhart answered that the projection is a maximum of 24 people at full build out.
- It was asked if the plan was to construct one or two level units. Mr. Lockhart answered that the Church is planning on all ground level units as that has been identified as the need.
- What is the average size of each unit? Current plans are: 1015sq ft for the 2 bedroom unit and approximately 682sq ft for single units.
- Are applications for Church Membership only? First come, first serve: yes. But vacancies will be made available to other community members.
- What is the construction timeline? Mr. Lockhart answered that the Church is hoping
  to see ground break this year and added that all funding for the project is coming
  from personal donations from their membership and the community.
