#### 3. PETITIONS AND DELEGATIONS

a. RCMP, Barriere Detachment Annual Update – Cpl. Rob Welsman

Cpl. Welsman provided Council with an update on the Barriere RCMP Detachment and an overview of its priorities over the past year:

- 2020 slight decrease in overall file count (1368 calls for service). Primary calls are for assistance, traffic and wellbeing checks or other mental health assistance.
- Domestic violence and assaults.

- The Detachment recently recovered a large amount of stolen items from repeat offenders.
- The BC National Service has announced some changes:

Promoting alternatives to prosecution – requires Crown Counsel to consider all prosecution options

Promoting sentencing alternatives – Asks for Crown to look at all alternatives to putting a person into custody when it may be appropriate for other measures (house arrest, curfew, etc.)

- Barriere Detachment staffing has remained stable.
- Anticipating changes to Policing costs due to salary reviews
- Due to COVID-19 regulations, school involvement has been reduced.
