## b. Cpl. Camalush, RCMP re: Policing Priorities -

Cpl. Camalush reported to Council that as a result of the detachment's recent "Community Policing Survey" the following three key priorities were identified:

- > Fraud/Scams
- Traffic Safety
- Property Crime/Theft

## In response, the Barriere RCMP has:

- ✓ held approximately four Fraud/Scam seminars in the community this year;
- ✓ increased police visibility in town and on Hwy 5 for traffic safety;
- √ increased communication with local media; and
- ✓ been working together with neighbouring detachments.

### Key statistics from the survey noted that:

- 83% of people said they feel very safe in Barriere slightly less so at night;
- > 52% said there are too few detachment members in Barriere;
- ➤ 66% said they feel very comfortable approaching Barriere RCMP his team is working on increasing this number; and
- ➤ 83% said they were very satisfied with the contact availability of the detachment.

  - i. Karen Smith & Julie Biller Emails re: Street Light Modification Request

An additional email from Ron and Debbie Hall supporting Karen Smith's email, was distributed to Council. The three emails are requesting that Council resolve their complaint of light pollution and glare from the two streetlights located on Barriere Town Road at the rear of their Oriole Road property were discussed.

The Public Works Manager reported that BC Hydro has relayed that any type of shielding or re-directing of the lights is not possible. The LED lights, installed by BC Hydro approximately 18 months ago, adhere to their own guidelines and that the MOTI guidelines, as quoted by Ms. Smith in her correspondence, are not relevant to municipal lighting installed by BC Hydro. The lights meet BC Hydro guidelines for kelvin/wattage and reach along main roadways such as Barriere Town Road. BC Hydro has explained that safety of pedestrians and vehicular traffic are the priority considered in establishing these guidelines. Replacing the lamps in question with a lower kelvin recommended for low-traffic, neighbourhood streets to 3,000k from the current 4,000k, would cost the taxpayers approximately \$1,500 per installation, as well as a precedent. This precedent could ultimately result in up to 80 streetlights being asked for similar modifications, against BC Hydro guidelines, totaling up to a cost to the taxpayer of \$120,000.

It was agreed that the issue continue to be recognized and if any other feasible options are found by staff that they be brought forward to Council for further discussion.
