a. Barriere Community Christmas Dinner - Lana Laskovic

Ms. Laskovic was in attendance and provided Council with an overview of this year's, planned Community Christmas Dinner. This event is now in its 5th year with an average of 125 meals made. This year will be a combination of a sit down meal at the Lions Hall as well as a delivery service. At present, there are 150 registrants for this year's dinner with more sure to come.

Ms. Laskovic reported that the event currently has \$3,688 in its account and has applied to the TNRD for an additional \$1000. She requested that Council honors a donation of \$500 from the District to cover any shortfalls.
